SECTION 3: HAZARDS IDENTIFICATION

3.1 EMERGENCY OVERVIEW

4.1 FIRST AID PROCEDURES

SECTION 6: ACCIDENTAL RELEASE MEASURES

SECTION 7: HANDLING AND STORAGE

7.1 HANDLING

Keep away from heat, sparks, open flame, pilot lights and other sources of ignition. Avoid contact with oxidizing agents. If ventilation is not adequate, use respiratory protection equipment.

7.2 STORAGE
